TUITION: A **NON-REFUNDABLE/NON-TRANSFERABLE** tuition deposit of \$200.00 is due by February 15th. The deposit will be applied to the total annual tuition. The payment schedule reflects three payment plans. Annual payments reflect a 3% discount. All payments are **NON-REFUNDABLE** and **NON-TRANSFERABLE**.

TESTING FEE: Current Child Enrichment Center and Early Childhood students who are re-enrolling do not have testing fees. Holy Spirit Episcopal School administers the BRIGANCE II to prospective students applying to Early Childhood for a fee of \$25. The testing is administered on our campus.
