



Application Fee

A **non-refundable/non-transferable** application fee of \$75.00 is due at the time an Application for Admission is submitted for all new students applying to Holy Spirit Episcopal School.

Tuition

A **non-refundable/non-transferable** tuition deposit of \$200.00 is due with the Enrollment Contract. This deposit will be applied to the total annual tuition. The Tuition Schedule reflects three payment plans. Annual payment plans reflect a discount. All payments are **non-refundable and non-transferable**.
